TERMS AND CONDITIONS

The initial term of this contract shall be from _____ through _____. Any additional services performed shall be paid for at the agreed rate and are due upon Pet owner's return.

Pet Sitting services will be provided at the rate of \$ _____ per night for boarding of one dog. Rates for subsequent services are subject to change.

All boarding fees under this contract are to be paid in advance, by check or cash. Pet owner takes full responsibility for prompt payment of fees. A finance charge of 10% per month will be added to unpaid balances after thirty (30) days. A handling fee of \$30 will be charged on all returned checks. In the event it is necessary to initiate collection proceedings on this account, Pet owner will be responsible for all attorney's fees and costs of collection.

Pet owner agrees to allow his/her pet(s) to remain at RSPR where other animals are present for the duration of the boarding term. Pet owner understands there is risk involved if the pet is not current on all vaccinations.

Due to the unpredictability of animals, we cannot accept responsibility for any mishaps of an extraordinary nature (i.e. biting, illness, accidental death, etc.) or any complications in administering medications to the animal

RSPR staff is authorized to perform care and services as outlined in this contract and the customer profile. RSPR is also authorized by signature below to seek emergency veterinary care with release from all liabilities related to transportation, treatment and expenses. RSPR is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by veterinarian, up to \$_____. Medical and/or emergency expenses above the authorized limit must be approved, in advance, by Pet owner. Pet owner agrees to reimburse RSPR for expenses incurred, plus any additional fees for attending to this need or any expenses incurred for any other home/food/supplies needed.

In the event of inclement weather or natural disaster, RSPR entrusted to use best judgment in caring for pet(s). RSPR will be held harmless for consequences related to such decisions. RSPR agrees to provide the services stated in this contract in a reliable, caring, and trustworthy manner. In Consideration thereof, the Pet owner expressly waives and relinquishes any and all claims against said RSPR/Company except those arising from negligence or willful misconduct on the part of the RSPR/Company.

Should an RSPR employee be bitten or otherwise exposed to any disease or ailment received from Pet owner's animal(s), it will be the Pet owner's responsibility to pay all costs and damages incurred by the victim.

RSPR/Company reserves the right to terminate services at any time before or during its term if RSPR/Company, in its sole discretion, determines that Pet owner's pet(s) pose a danger to the health or safety of RSPR staff.

Pet owner authorizes this signed contract to be valid approval for future services of any purpose provided by this contract, permitting RSPR/Company to accept telephone reservations for service without additional signed contracts or written authorization.
